# 193. Apologies for Absence

Apologies were received from Cllr Ms Birley, Cllr Mrs Gaskell and Cllr Bell and the reasons for absence was accepted.

No declarations were made for the agenda items.

# 195. <u>Planning Applications.</u>

15592/22 Valynette

Councillors made no objections to the planning application

## 15568/23 land adj 12, Chapel Street

Councillors heard from residents on the planning application prior to consideration being given by members.

Councillors indicated that the report provided by United Utilities should be addressed in regard to close proximity of pipeline that relates to sewerage and waste water disposal and any diversion agreements and the applicant should consider their drainage plans accordingly.

The Town Council has also expressed concerns on the access to affected roads (Boardman Street and Chapel Street) where parking is extremely limited.

References to previous applications for the original 2 sites in that area, which has become one, should not be observed when considering this application.

There is a table reference within the Design and Access statement made by the applicant which simply does not exist and should be disregarded.

There are some concerns in relation to the boundary lines as well as the plans appearing to encroach on to current roadside areas

The design of the building is not in keeping with houses in the area and other concerns are made in relation to appropriate distances from other developments.

Councillors voted to reject the application with a request that a full site visit be made by the planning committee and not just through references to previous applications, which in themselves resulted in no actual site visits by Bolton Planning Team.

A local resident brought the conditions in regard to Dark Lane to the attention of the Town Council. Following hearing the issue, the Town Clerk asked the local resident to provide her with some photographs, which are beneficial to matters being raised. The resident agreed to send the photographs to the Town Clerk.

Another local resident brought matters concerning the disgraceful condition of Station road to the attention of members. The resident indicated that a group of residents had met with **a** Bolton Council Assistant Director for Environment Services who had had contact with both residents, the Town Council and Ward Councillor Mrs Baines over the issue and following listening to the list of issues the resident raised it was proposed by Councillor Farrington and seconded by Councillor Mrs Seddon that the

Town Clerk make a request to Bolton Council via the Director to obtain two reports which had been undertaken on the pollution issues in that area.

Confirmation has taken place with Senior Officers and Medical Teams that Blackrod Health Centre will not be closing

A new neighbourhood model will be implemented by Bolton Council with Blackrod selected as a pilot. This involves changes to funding that is managed by the 3 Ward Councillors and makes it more accessible to volunteer groups.
